# Technical information about this website's accessibility

East Challow Parish Council is committed to making its website accessible, in accordance with the Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018.

The site is managed using the IONOS 1&1 MyWebSite content management system. Some elements of the website design coding are not available for user customisation in this system.

### **Compliance status**

This website is partially compliant with the <u>Web Content Accessibility Guidelines version</u> <u>2.1</u> AA standard, due to the non-compliances listed below.

# Non-accessible content

The content listed below is non-accessible for the following reasons.

## Non-compliance with the accessibility regulations

It is not possible to modify the line height or spacing of text.

It is not possible to change the fonts or colours used.

Some images do not have a text alternative, so people using a screen reader cannot access the information. This fails WCAG 2.1 success criterion 1.1.1 (non-text content).

When we publish new content we'll make sure our use of images meets accessibility standards.

### Disproportionate burden

Some archive documentation is not in fully screen reader compatible format.

Some documents referring third party services is in the form of scanned images.

### Navigation and accessing information

There's no way to skip the repeated content in the page header (for example, a 'skip to main content' option).

### Interactive tools and transactions

We've assessed the cost of fixing the issues with navigation and accessing information, and with interactive tools and transactions. We believe that doing so now would be a <u>disproportionate burden</u> within the meaning of the accessibility regulations. We will make another assessment when the supplier contract is up for renewal.

## Content that's not within the scope of the accessibility regulations

#### PDFs and other documents

The accessibility regulations do not require us to fix PDFs or other documents published before 23 September 2018 if they're not essential to providing our services. For example, we do not plan to fix pre-September 2018 Parish Council meeting minutes and other archival documentation.

Any new PDFs or Word documents we publish will meet accessibility standards.

#### Live video

We do not plan to add captions to live video streams because live video is <u>exempt from meeting the accessibility regulations</u>. At present the site has no live or recorded video streams.

# What we're doing to improve accessibility

When adding new material or redesigning the website, we will be careful to ensure that accessibility requirements are followed as closely as possible.
