EAST CHALLOW PARISH COUNCIL MINUTES OF THE MEETING HELD ON WEDNESDAY 9th NOVEMBER 2022

In Attendance: Ms V Bosley (Chair), Mrs F Webb, Mr T Hayes, Mr P Barrow.

Five members of the public, one member of the public (part of the meeting).

The Clerk texted the Chair at 5pm today to inform her that she would not be attending the meeting due to illness. The Chair undertook to take notes of the proceedings of the meeting.

141/22 DECLARATION OF INTERESTS

The Chairman invited councillors to declare any interests in matters about to be discussed and to declare an interest if any items in which they have an interest arise during the course of the meeting. No declarations were made.

142/22 MINUTES OF 12th OCTOBER 2022

Item 122/22. Cllr Webb noted the incorrect date of minutes to be accepted at the October meeting which should have read 20th July.

Cllr Webb proposed and Cllr Hayes seconded approval of the minutes of the Parish Council Meeting held on 12th October 2022.

143/22 PUBLIC DISCUSION TIME

Hedgerows

Cllr Barrow and Mr A Barclay (of West Challow) spoke about their project to re-instate hedgerows and cut grips in roadside verges within the local parishes of East and West Challow and Childrey. A joint venture would be good, they are looking for volunteers to assist, information on the venture will be put on village Facebook pages and websites. There is an app which can be used to show hedges, land buffers and to identify landowners.

Mr Barclay commented on the disappearance of hedges on Whitelands Lane/Silver Lane over the 30 years he has lived in West Challow. It is intended to make contact with Mr N Adams who is known to be investigating saving hedgerows. This will be a long-term project.

Canal Way Development

Two members of the public spoke about their objections to the proposed Bewley Houses proposal for 55 houses at the end of Canal Way.

Cllr Barrow spoke about the screening assessment which took place last month.

Concerns were about the population increase; loss of separation between East Challow and Wantage; the high-water table; loss of wildlife; heavy traffic and increased traffic along Canal Way; access onto the A417; the previous year's screening, proposal for 200 houses opposite King Alfred's School.

Other arguments against this proposal were the same as for the Crest Nicolson and McTaggart & Mickel developments.

Cllr Webb spoke on relaxed planning regulation.

Cllr Barrow spoke on housing figures/NPPF and the local plan.

Issues have arisen due to the Vale putting out a call for potential development sites.

The Park footpath closure was mentioned as well as the canal towpath.
